1           Plaintiffs have demonstrated that they are likely to succeed on the merits of  
2 their claim that California Health & Safety Code, §120325, *et seq.* violates their  
3 federal constitutional rights to due process and equal protection. Plaintiffs have  
4 also established that this harm is irreparable, the balance of equities weighs in their  
5 favor, and injunctive relief will promote the public interest. Therefore, the Court  
6 finds that Plaintiffs’ Motion for a Preliminary Injunction should be **GRANTED**.

7           **IT IS THEREFORE ORDERED** that Defendants are hereby enjoined from  
8 enforcing California Health & Safety Code, §120325, *et seq.*, until this Court orders  
9 otherwise.
